THE AMENDMENTS FOR OUR LOCAL BRANCH IMA NASHIK ROAD.

NAME OF THE BRANCH WILL APPEAR AS "IMA NASHIKROAD."

IMA SHOULD HAVE AT LEAST TWO [2] GENERAL BODY MEETING WITH DETAIL AGENDA AND AN EXTRAORDINARY GENERAL BODY MEETING WITH SPECIAL/SPECIFIC AGENDA IF NEEDED WITH DUE NOTICE. GENERAL BODY MEETING SHOULD BE ANNOUNCED WITH 15 DAYS PRIOR NOTICE AND AUDITED ACCOUNTS SHOULD BE MADE AVAILABLE FOR ALL MEMBERS FROM THE DATE OF ANNOUNCEMENT OF GENERAL BODY MEETING.

ELECTION OFFICERS :-

MINIMUM THREE [3] IN NUMBERS, SHOULD BE A REGULAR BRANCH MEMBER FOR MINIMUM 15 YEARS AND A LIFE MEMBER OF CENTRAL IMA, IMA NASHIK ROAD, SHOULD HAVE WORKED IN WORKING / EXECUTIVE COMMITTEE WITHOUT ANY DUES. # ELECTION COMMITTEE TO BE NOMINATED BY THE REIGNING PRESIDENT AND HIS TEAM.

ELIGIBILITY FOR PRESIDENT / PRESIDENT ELECT :-

MINIMUM SEVEN [7] YEARS OF REGULAR BRANCH MEMBER WITH WORKING EXPERIENCE OF SECRETARY OR TREASURER AND WITHOUT ANY DUES. SHOULD BE A LIFE MEMBER OF IMA.

ELIGIBILITY FOR SECRETARY / TREASURER :-

MINIMUM THREE [3] YEARS OF REGULAR BRANCH MEMBER WITHOUT ANY DUES. # IN CASE A PROPER CANDIDATE IS NOT AVAILABLE TO FULFILL THESE CRITERIA IT WILL BE AT THE HANDS OF THE ELECTION COMMITTEE TO RELAX THE CRITERIA AND TAKE PROPER DECISIONS.

EXECUTIVE COMMITTEE :-

DEPENDING ON THE NUMBER OF MEMBERS ---e.g. FOR MEMBERS UP TO 200 – SHALL CONSIST OF 16 MEMBERS + PRESIDENT, VICE PRESIDENT, PRESIDENT ELECT, SECRETARY & TREASURER = TOTAL 21.

VOTER ELIGIBILITY :-

ONLY REGULAR ANNUAL AND LIFE MEMBERS OF BRANCH AND SHOULD HAVE PAID THE FEES BEFORE 30TH JUNE OF THAT YEAR.

FINANCIAL INVESTMENT :-

LIKE FIXED DEPOSITS ONLY IN NATIONALISED BANKS. WITHDRAWALS FROM FDs OR CORE FUNDS [GANGA-JALI] SHOULD BE WITH PERMISSION OF GENERAL BODY MEETING ONLY.

FEES STRUCTURE TO BE DECIDED IN GENERAL BODY MEETING AS PER GUIDELINES :-

ANNUAL REGULAR MEMBER # LIFE MEMBER # ASSOCIATE MEMBER FEES DIFFERENCE BETWEEN ANNUAL REGULAR AND LIFE MEMBER SHOULD BE CALCULATED CONSIDERING THE HFC [HEADQUARTERS FRATERNITY CONTRIBUTION] TO BE PAID TO THE CENTRAL IMA. e.g. LIFE MEMBER SHOULD PAY ANNUAL REGULAR FEES MINUS [-] HFC [ROUNDED UP] ASSOCIATE MEMBERS ALSO TO BE CHARGED LIKE LIFE MEMBERS / SUBSIDY OF 25%. FEES TO BE DECIDED IN GENERAL BODY MEETING WITH MAXIMUM 10% INCREASE EVERY YEAR. MEMBERS ABOVE 75 YEARS AGE SHOULD BE CALLED AS HONORARY MEMBERS AND SHOULD NOT BE CHARGED FOR ANY FEES.

ONLY MEMBERS OF OTHER IMA BRANCH [MBBS AND ABOVE] AND DENTISTS CAN BECOME ASSOCIATE MEMBERS OF OUR BRANCH AND WILL NOT HAVE ANY VOTING POWER IF REQUIRED AT / ON ANY POINT- LIKE ELECTIONS AND OTHER POLICY DECISIONS.

RULES AND REGULATIONS :-

RULES AND REGULATIONS SHOULD BE FOLLOWED BY ALL MEMBERS OTHERWISE CAN BE SUSPENDED / REMOVED FROM THE MEMBERSHIP. ANY INDISCIPLINARY CONDUCT BY ANY MEMBER WILL BE LIABLE FOR STRICT ACTION.
